

## Youth Ambassador Programme For Tertiary Students

#### **BACKGROUND**

VM Group began operations with The VM Building Society (VMBS) which first opened its doors in 1878. Our founders, a group of clergymen, led by then Rector of the Kingston Parish Church, Reverend G.W. Downer, formed VMBS with a vision of "meeting the needs of the deserving thrifty".

# JOB DESCRIPTION Criteria

#### The VM FETE Youth Ambassador:

- Should be a student of the institution in which the VM Financial Education To Empower Youth Ambassador Programme will be carried out
- Must maintain at least a B average or at least a GPA of 3.0

- 3. Must not be in final year of study upon first application (Nb. A VM FETE Youth Ambassador can be a final year student but should not be in final year when he/she is applying for the first time)
- **4.** Should possess above average oral and written communication skills
- 5. Should be a member of at least one extra curricular or community-based volunteer activity
- 6. Should not be an individual of questionable character; must have a history of demonstrating good moral and ethical character and must not have a history of drug or alcohol abuse within the past year
- Must not have any criminal or legal charges currently or be under an investigation for any such charges
- 8. Should not be a promoter of another financial institution within the period of engagement
- Should receive two Character References from an adult other than their parents (e.g. teachers, coaches, clergy, social worker, doctors, etc.)

### **Roles and Responsibilities**

# The VM FETE Ambassador will be required to:

- Complete VM FETE Financial Literacy training
- 2. Arrange Financial Education
  Training sessions to engage at least
  50 participants per month.
- 3. Submit at least 5 referrals per semester that would allow us to successfully land new business

**4.** Participate in Member and Corporate events.

### **Remuneration and Benefits**

# The VM Financial Education Youth Ambassador will benefit from:

- 1. A basic monthly stipend of J\$10,000.00 to be deposited to VMBS Savings Account (NB. This is based on achievement of point number 2 in Roles and Responsibilities)
- A special bonus at the end of the semester if target for new business is met or surpassed
- 3. Interaction and coaching sessions with VM Executives
- **4.** Participation in VM Team Member and Corporate events

    - f. Attorney at Law

    - h. Medical Practitioner
- A panel comprising representatives from the VM Group will interview applicants and make final selection based on agreed rubric.
