

- **2.** Any alteration made in this Form of Proxy should be initialed by the person who signs it.

In the case of joint holders the vote of the senior joint holder who tenders a vote whether in person or by proxy will be accepted to the exclusion of the votes of the other joint holders(s), and for this purpose seniority will be determined by the order in which the names appear in the books of the Society.
